

MEDIA CONSENT & RELEASE

THIS CONSENT & RELEASE (the "Release"), is made and entered into this ___ day of _____ 2008 by and between the Lawyers' Committee for Civil Rights Under Law, a non profit corporation organized under the laws of the District of Columbia and having its principal place of business at 1401 New York Avenue, NW, Suite 400, Washington, DC 20005("LAWYERS COMMITTEE") and [Name]_____ an individual residing at [Address]_____ ("INDIVIDUAL").

WHEREAS, LAWYERS COMMITTEE wishes to use one or more photographs depicting INDIVIDUAL for promotion and advertising, including in printed materials and on the Internet; and

WHEREAS, INDIVIDUAL consents to the use of the photograph(s) by LAWYERS COMMITTEE.

NOW THEREFORE, INDIVIDUAL hereby unconditionally grants to LAWYERS COMMITTEE certain rights as described below.

1. INDIVIDUAL hereby irrevocably assigns to LAWYERS COMMITTEE: (a) the exclusive, irrevocable, unrestricted and perpetual right throughout the world, to record, film, tape, video tape, photograph, broadcast (whether by wire, satellite, laser, cable or any other means whatsoever), reproduce, distribute, adapt, transmit, publicly perform, publicly display and otherwise use and make copies, in whole or in part, of one or more photographs depicting INDIVIDUAL alone or with a group (the "Photographs"), including without limitation, by incorporating said Photographs in printed materials and posting on LAWYERS COMMITTEE's Internet web site; and (b) the irrevocable, unrestricted and perpetual right throughout the world to reproduce, distribute, transmit, print, publish and disseminate, in any medium whatsoever, INDIVIDUAL's name, likeness and biographical information, including for the purposes of trade and/or advertising.

2. All right, title and interest in and to the Photographs, as between INDIVIDUAL and LAWYERS COMMITTEE, shall be the sole property of LAWYERS COMMITTEE, free from any claims whatsoever by INDIVIDUAL or any person deriving any rights or interests from INDIVIDUAL. In this connection INDIVIDUAL acknowledges that LAWYERS COMMITTEE may seek the registration of the copyrights in one or more of the Photographs in LAWYERS COMMITTEE's name as the owner and author thereof and to secure any and all applicable renewals and extensions of such copyright, without any interference from INDIVIDUAL.

3. Notwithstanding the foregoing, LAWYERS COMMITTEE has no obligation or duty to use the Photographs in whole or in part.

4. INDIVIDUAL shall not receive any compensation in connection with: (a) the use and exploitation of the Photographs; or (b) the exercise of the rights granted to LAWYERS COMMITTEE herein.

5. INDIVIDUAL hereby warrants that he/she is of full age and has the right to execute this Release. INDIVIDUAL further warrants and represents that, to the best of his/her knowledge and belief, INDIVIDUAL has not violated the rights of any third parties in executing this Release. INDIVIDUAL further warrants and represents that he/she will indemnify and hold harmless LAWYERS COMMITTEE, and its respective officers, directors, shareholders, agents, attorneys, employees, parents, affiliates, distributors, successors, licensees, and assigns from any and all losses, costs, and/or expenses arising out of a breach of the foregoing warranties. INDIVIDUAL represents that he/she has read this Release carefully and understand the contents. This Release shall be binding upon INDIVIDUAL and his/her heirs, legal representatives, and assigns.
